Healthy House, Inc., a Texas corporation ("**Healthy House**," "**our**," "**us**," or "**we**") respects your privacy. In that regard, we have created this Privacy Policy to let you know what information we collect when you visit our site, why we collect it, and how it is used. This Privacy Policy governs the privacy guidelines for Healthy House's website at www.myhealthyhouse.com (the "**Website**"). By using the Website, you consent to the data practices prescribed in this Privacy Policy.

What information does Healthy House collect?

"**Personal Information**" means any information that may be used to identify an individual, including, but not limited to, first and last name, home or other physical address, an email address, phone number, or other contact information, whether at work or at home, age information, information about dependents, and information about real or personal property.

In a few areas on our Website, we ask you to provide Personal Information that will enable us to enhance your use of the Website or for purposes such as facilitating correspondence with you, registering your entitlement to access certain special features of the Website or enabling use of such features, or to complete transactions. It is always your choice whether or not to provide that Personal Information. If you choose not to provide requested Personal Information, you may not be able to use certain features of the Website.

We may also automatically receive and record information on our server logs from your browser, which could include your IP address, cookie information, browser information, and the page you request. This information is not deemed by Healthy House to constitute Personal Information and while Healthy House will not use it in a way that associates such information with you, such information it may be aggregated and used. Healthy House owns this information and may use it in any manner it deems appropriate.

How does Healthy House use Personal Information?

The Personal Information you provide will be kept confidential and used to support your relationship with Healthy House and use our products and services. Among other things, we want to help you quickly find information on our Website, leverage our tools in connection with your authorized use of our products and services, and alert you to product upgrades, special offers, updated information and other new products and services from Healthy House.

Information Sharing and Disclosure to Third Parties

Except as set forth herein or in any terms of service between you and Healthy House, Healthy House does not rent, sell or share Personal Information it collects about you to or with third parties, and Personal Information collected from you is only used to provide you with Healthy House products and services and to comply with any requirements of law.

Agents or Service Providers of Healthy House may have access to your Personal Information for the purpose of performing services on behalf of Healthy House. All such agents or Service Providers who have access to your Personal Information are required to keep the information confidential and not use it for any other purpose than to carry out the services they are performing for Healthy House or as otherwise required by law.

In addition, Personal Information collected about you may be shared with other third parties as contemplated by the Terms of Service, as expressly stated on the page on which you provided such information, or if you request that we make such information available to third parties.

Healthy House or its agents or Service Providers may disclose Personal Information if required to do so by law or in the good faith belief that such action is necessary to: (1) conform to the edicts of the

law or comply with legal process; (2) protect and defend the rights or property of Healthy House or its agents or Service Providers; or (3) act in urgent circumstances to protect the personal safety of users of Healthy House, its Websites or the public.

Finally, if Healthy House should ever file for bankruptcy or merge with another company or sell our assets, we may sell or transfer the information you provide to us on this Website to a third party or share your Personal Information to the company with which we enter into such transaction as a part of such transaction.

Security of Your Information

We maintain physical, electronic, and procedural safeguards designed to protect Personal Information.

Further, our employees and third party service providers have access to your nonpublic Personal Information only on a "need to know" basis. We internally audit our business practices and procedures, examining confidentiality standards and information access in order to protect your Personal Information.

Despite the actions and precautions we take, no data transmissions over the Internet can be guaranteed to be 100% secure. Consequently, we cannot ensure or warrant the security of your Personal Information and you transmit it to us at your own risk.

Please keep in mind that whenever you voluntarily disclose Personal Information on our message boards or other public forums or features, through e-mail, or in chat areas, that information can be collected and used by others. In short, by posting Personal Information online that is publicly accessible, you may receive unsolicited messages from other parties in return. We are not responsible for the security or privacy of any Personal Information you choose to submit in connection with these public features.

We may send an email to you at the email address you have provided to us in the event of a security breach. Depending on where you live, you may have a legal right to receive notice of a security breach in writing. To receive free written notice of a security breach (or to withdraw your consent from receiving electronic notice) you should notify us at help@myhealthyhouse.com.

Third-Party Websites

Please be aware that other websites, including the websites of third parties that you connect with through our Website, may collect personally identifiable information about you. This Privacy Policy does not cover the information practices of those third-party websites linked to our Website.

International Transfers

Personal Information collected on this Website may be stored and processed in the United States or any other country in which Healthy House or its affiliates, subsidiaries, agents or Service Providers maintain facilities, and by using this Website, you consent to any such transfer of information outside of your country.

Your continued use of this Website constitutes your agreement to this Privacy Policy and any updates.
